The recycling of industrial waste into a new long lasting product is an enormous contribution to help to reduce energy and disposal of potentially continuous waste to landfill.

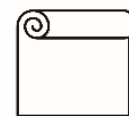
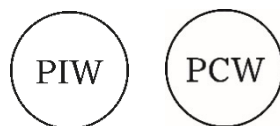
SUEDEL® LUXE RECYCLED is using a recycled paper base from our WIBALIN® RECYCLED range and recycled cotton from industrial waste to create a unique and durable cover material for objects that are supposed to inspire at the first touch.

The production of cotton generates waste. We collect, clean and process it into a high quality flock material, which is then applied onto WIBALIN® RECYCLED. The result of this WINTER WRUP-Cycling circular model is SUEDEL® LUXE RECYCLED, a new sustainable material with an elegant suede leather appearance and a pleasant soft touch.



POST INDUSTRIAL WASTE & POST CONSUMER WASTE

In the industrial transformation of raw cotton, a percentage of the natural fibres is becoming Post Industrial Waste. This waste is used in our upcycled product SUEDEL® LUXE RECYCLED. Through this process, we avoid the need of newly resourced cotton fibres. By using our WIBALIN® RECYCLED as base paper we also take back, in a product of quality, Post Industrial Waste as well as Post Consumer Waste, coming from already consumed paper waste. Also, this process avoids the need of a quantity of virgin pulp paper.
